### **Available End User Licences**

Blyenburgh & Co commercialises documents such as annual reference publications, specialized dictionaries, terminology listings, proceedings of conferences organized by Blyenburgh & Co, and various other documents, published by B&C, as well as by third party Publishers, principally in electronic format, but in some cases also in hardcopy format (e.g. the annual publication entitled "RPAS: The Global Perspective").

The following End User Licence agreements are available for the purchase of access to electronic documents published by Blyenburgh & Co, or by third party publishers and that are commercialised by Blyenburgh & Co.

All end user licences are subject to Blyenburgh & Co's General Terms & Conditions.

#### **Single End User Licence**

This Licence allows for use of a purchased Document by only one person, the declared single user. By using the ordered publication, the declared single user agrees to adhere to the terms of this license. The declared single user is responsible for the use of the contents of the Document. The information contained in the Document may not be shared with other company sites or work teams or persons in the same or other companies in any form; neither may it be photocopied nor reproduced, including for internal use. The content of the Document may not be stored, transferred, or copied to any type of electronic storage device. No parts of the Document may be reproduced, posted on a web site, stored in a retrieval system (including an intranet), transferred or transmitted in any form or by any means, electronic, mechanical, photocopying, recording or otherwise, without prior written permission. No part or extract, in any format whatsoever, may be transmitted to any other organization, including cooperative entities and subsidiaries. Each of these persons may use the Document on its computer, and may print out the Document, but may not share the Document (or any information contained therein) with any other person or persons.

#### **Single-Company Single-Site Unlimited End User Licence**

This Licence allows for use of a purchased Document by an unlimited number of persons within the same enterprise or organisation (including public & private centres of learning, e.g. universities, faculties, academies, schools) in a single physical location for a specified period of time. Each of these persons may use the Document on any computer, and may print out the document, but may not share the Document (or any information contained therein) with any person or persons outside of the enterprise's or organisation's location.

#### **Single-Company Multi-Site Single-Country Unlimited End User Licence**

This Licence allows for use of a purchased Document by an unlimited number of persons within the same enterprise or organisation at an unlimited number of physical locations in the same country for a specified period of time. Each of these persons may use the Document on any computer, and may print out the document, but may not share the Document (or any information contained therein) with any person or persons outside of the enterprise's or organisation's physical locations in the same country.

#### **Single-Company Multi-Site Multi-Country Unlimited End User Licence**

This Licence allows for use of a Document by an unlimited number of persons within the same enterprise or organisation at its physical locations worldwide for a specified period of time. Each of these persons may use the Document on any computer, and may print out the Document, but may not share the Document (or any information contained therein) with any other person or persons outside of its enterprise or organisation.
